

## Regulatory Compliance Overview

AGROWLYTE is a powerful, safe, and sustainable hypochlorous acid (HOCl) solution designed for agricultural and food industry applications. It complies with federal regulations for use as an antimicrobial and disinfectant, including food-contact surfaces, organic crop and livestock production, and direct crop/food contact applications. AGROWLYTE is EPA-registered, USDA Organic-approved, and conforms to FDA regulations.

### EPA Tolerance Exemption for Hypochlorous Acid:

- 40 CFR § 180.940 - Allows use as an antimicrobial solution up to 200 PPM total available chlorine for food-contact surfaces.

- Permitted as a sanitizer for food-contact surfaces up to 200 PPM total chlorine.
